Anti-Bullying Policy

Statement of Intent

At Elizabeth North Primary School we are committed to providing a caring, friendly and safe environment for all of our students so they can learn in a safe and secure atmosphere. Bullying of any kind is unacceptable at Elizabeth North. If bullying does occur, all students should be able to tell and know that incidents will be dealt with promptly and effectively. We are a 'telling' school, which means that *anyone* who knows that bullying is happening is expected to tell school staff.

Objectives of this Policy

- All staff, students and parents should have an understanding of what bullying is.
- All staff should know the Anti-Bullying Policy and follow it when bullying is reported.
- All students and parents should know the Anti-Bullying Policy and what they should do if bullying occurs.
- As a school we take bullying seriously. Students and parents should be assured that they will be supported when bullying is reported.
- Bullying of any description will not be tolerated.

What Is Bullying?

Bullying is the use of targeted, intentional and ongoing unwanted behaviour towards another student(s) with the intention of hurting, either physically or emotionally. Bullying is not a 'one off' incident of harassment or teasing.

Bullying can be:

- Emotional deliberately excluding another student.
- Physical pushing, kicking, hitting, punching or any use of violence.
- Racist racial taunts about skin colour, culture or religion.
- Sexual unwanted physical contact or sexually abusive comments.
- Homophobic focussing on a student's sexuality.
- Verbal name-calling, threats, sarcasm, spreading rumours or teasing.
- Cyber all areas of internet, such as using social media as a means of harassing another student. Mobile phone threats by text messaging and calls. Misuse of associated technology, i.e. camera and video facilities.
- Bystander watching bullying occur and not doing something to stop it and / or reporting it.

Why is it important to respond to Bullying?

Bullying hurts. No one deserves to be a victim of bullying. Everybody has the right to be treated with respect. Students who are bullying need to learn different ways of behaving.

As a school we have a responsibility to respond promptly and effectively to issues of bullying.

Signs and Symptoms

A child may indicate by signs or behaviour that he or she is being bullied. Adults should be aware of these possible signs and that they should investigate if a child:

- is frightened of walking to or from school
- begs to be driven to school
- changes their usual routine
- is unwilling to go to school (school phobic)
- begins to truant
- becomes withdrawn anxious, or lacking in confidence
- attempts or threatens suicide or runs away
- cries themselves to sleep at night or has nightmares
- feels ill in the morning

- begins to do poorly in school work
 - comes home with clothes torn or books damaged
 - has possessions which are damaged or " go missing"
 - asks for money or starts stealing money (to pay bully)
 - has unexplained cuts or bruises
 - is nervous & jumpy when a cyber message is received
- These signs and behaviours could indicate other problems, but bullying should be considered a possibility and should be investigated.

Procedures – What will the school do when a report of bullying occurs?

1. Report bullying incidents to staff immediately. Use the Grievance Procedures to report bullying.
2. The bullying behaviour or threats of bullying will be investigated. This will include documentation of the bullying issue.
3. In serious cases parents will be informed and will be asked to come in to a meeting to discuss the problem.
4. The victim of bullying will be involved / informed of progress towards resolving the bullying issue.
5. If necessary and appropriate, police will be consulted.
6. An attempt will be made to help the bully (bullies) change their behaviour.

Outcomes – What will happen as an outcome of the investigation in to bullying?

1. The bully (bullies) will be asked to genuinely apologise. Other consequences will also take place.
2. In serious cases, suspension or even exclusion will be considered.
3. If possible, the students will be reconciled.
4. After the incident / incidents have been investigated and dealt with, each case will be monitored to ensure repeated bullying does not take place.

Prevention – What does the school do as part of the curriculum?

We will use a number of methods for helping students to prevent bullying. All teachers will use the Child Protection Curriculum as a reference for teaching students the skills to prevent, recognize and / or manage bullying. As and when appropriate, this may include:

- writing a set of school responsibilities and values,
- signing a behaviour contract,
- writing stories or poems or drawing pictures about bullying,
- reading stories about bullying or having them read to a class or assembly,
- making up role-plays,
- having discussions about bullying and why it matters.
